S SECURE OUR SYSTEMS AGAINST CHINA'S TACTICS

Background:

- CHINA IS LOOKING TO TAKE ADVANTAGE OF THE CORONAVIRUS CRISIS AND GOBBLE UP AMERICAN COMPANIES THAT ARE VITAL TO OUR NATIONAL DEFENSE WHILE THEY ARE ECONOMICALLY DISTRESSED AND IN NEED OF CAPITAL.
- THE BUSINESSES THAT SUPPLY THE EQUIPMENT, SYSTEMS, AND TECHNOLOGIES FOR OUR MILITARY ARE ESSENTIAL TO A STRONG U.S.
- WITHOUT A FULLY-ARMED SUPPLY CHAIN, WE WILL BE VULNERABLE TO ATTACK AND AT A COMPARATIVE DISADVANTAGE WITH CHINA.
- CHINA'S UNDERMINING OF THE U.S. AND STRATEGIC ALLIES HAS ALREADY BEEN OCCURING AT A RAPIDLY-RISING RATE THE LAST 10 YEARS.
- CHINA'S GOAL: TO BECOME THE WORLD'S SUPERPOWER AND DISPLACE THE UNITED STATES, TO LEAD FROM THE FRONT WITH THE EVIL, INHUMANE IDEOLOGY OF COMMUNISM.
- Uses \$10 billion from Sec. 4003(b)(4) of the CARES Act for investment guarantees.
- Backed up 50% if the company ultimately fails, providing added incentive to invest in the first place.

H.R. 6598

- **SOS ACT** For all companies of national security interest, as defined by
 - SECDEF and Sec. of State, at risk of being bought up in the wake of the coronavirus outbreak.
 - Prevents China from using this as a golden opportunity for the advantage of Chinese Communist Party officials and the severe disadvantage of every Chinese citizen, American citizen, and all people on earth.

China is illegitimately using the whole array of geopolitical tools available (DIME).

- Holding countries hostage through "debt-trap diplomacy" with the highly-misleading Belt & Road Initiative.
- Building artificial islands in the South China Sea to make spurious claims of ownership and ignoring an international DIPLOMATIC court's condemnation of this encroaching on the sovereignty of the Philippines. Violating negotiations to curb intellectual property theft. Breaking democracy agreements with the semi-autonomous government of Hong Kong. Censoring domestic media to prevent their public from knowing the extent of the CCP's human rights violations on its own people and from being exposed to the benefits of democracy. • Using American companies' technology to spy on and INFORMATIONAL oppress the Chinese Muslim population. • Hijacking networks to destroy the world's privacy and security with backdoors already discovered in Italy by Vodafone and the African Union's network data being sent to Shanghai servers for 5 years. • Stealing blueprints from the United States' F-35 program and hacking other DOD records. Deploying forces in the South and East China Seas to scare **MILITARY** away others despite no legitimate legal claim. Assisting the Taliban economically and cooperating with the Taliban and al Qaeda militarily after 9/11.

• Outright theft of IP, especially from the US; e.g. state-backed Huawei's theft of Motorola's wireless tech.

Manipulating their currency to artificially inflate their ECONOMIC economy.

> Unfair trade practices that punish other countries while granting artificial advantage to domestic industry.
